

**SPRING TOWNSHIP SUPERVISORS**

The Spring Township Regular Monthly Meeting was called to order at 7:00 p.m. by Frank Royer, Chairman, followed by Pledge to the Flag.

**HEARING OF VISITORS:**

**Richard Carson – Carson’s Disposal Service** – Richard Carson was present to plead with the Supervisors to not accept the bid to go with regional collection. With the minimal savings of \$8 or \$9 this would not include recycling, plus he also includes Riff Raff collection upon request where as if the Township were to accept the bid, customers would have to hold their items for collection only twice a year. Mr. Carson also remarked “Hopefully seeing all the people in attendance would prove a lot.” Mr. Carson thanked the Supervisors and again asked they reconsider putting the trash service out for bid and to let people have the freedom of choice.

**Acceptance/Denial of Trash Collection/Recycling Bid** – Terry Perryman, Vice-Chairman, reported his big problem was he was not in favor of putting people out of business, and he doesn't feel government needs to be involved in these types of issues. After some discussion, Terry Perryman reported his vote is to deny at this point. Also commented to Mr. Carson that he feels communication is a real issue. David Capperella, Supervisor, reported he is also against bidding, feels government should regulate to help but not choose winners and losers, feels we must have freedom of choice. Frank Royer, Chairman, reported he can not believe a savings to residents wouldn't matter. Hauler's need to provide their customer list to the Township, which they are not complying with. Terry Perryman, Vice-Chairman, reported the hauler's need to provide their customer lists to help comply with the current regulations. David Capperella, Supervisor, commented he agrees, the haulers need to work with the Township.

It was on a motion of Frank Royer to accept the bid. With no second, motion died.

It was on a motion of Terry Perryman seconded by David Capperella to deny the bid and leave trash service as is with customers being able to choose who they want. Motion carried.
